Right of withdrawal

You have the right to withdraw from this contract within 14 days without giving any reason.

The withdrawal period will expire after 14 days from the day of the conclusion of the contract.

You may use the attached model withdrawal form, but it is not obligatory. You can also exercise your right of withdrawal online at <https://mobilepmu.com/en/withdrawal>. If you use this online feature, we will send you an acknowledgement of receipt of the withdrawal on a durable medium (e.g. by email), including its content and the date and time of its submission, without undue delay.

To meet the withdrawal deadline, it is sufficient for you to send your communication concerning your exercise of the right of withdrawal before the withdrawal period has expired.

Effects of withdrawal

If you withdraw from this contract, we shall reimburse to you all payments received from you, including the costs of delivery (with the exception of the supplementary costs resulting from your choice of a type of delivery other than the least expensive type of standard delivery offered by us), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. We will carry out such reimbursement using the same means of payment as you used for the initial transaction, unless you have expressly agreed otherwise; in any event, you will not incur any fees as a result of such reimbursement.

Early expiry of the right of withdrawal

For a contract for the supply of digital content which is not supplied on a tangible medium, your right of withdrawal expires early if we have begun performance after you have expressly consented to our beginning performance before the end of the withdrawal period, you have acknowledged that you thereby lose your right of withdrawal once performance has begun, and we have provided you with a confirmation of the contract under section 312f of the German Civil Code (BGB) on a durable medium (section 356(6) no. 2 BGB).

We begin performance when you start the download or retrieval of the content for the first time. If you did not consent to early performance, we make the content available only after the withdrawal period has ended.
